WALKING WITH WINNERS RECOVERY CENTERS

RULES

For the smooth and efficient running of Walking With Winners Recovery Centers and the protection of the community and its individuals, it is necessary to have rules. It is important to know what these rules are, and to be aware that failing to comply with some of them, will lead to your discharge from the treatment program. It is also necessary to know that management may amend the rules from time to time, without prior notice, as deemed fit by management.

Rules:

If you leave Walking With Winners, any belongings you leave behind, will become the property of Walking With Winners. By signing this agreement, you acknowledge that your goods and fees will be forfeited if you abscond, leave early and/or is expelled. Furthermore any and all belongings left behind will be handed out to the less fortunate.

Breaking rules will lead to your immediate discharge from treatment.

1. No using, or bringing onto the premises, any alcohol or any kind of drug, including prescription and non-prescription drugs at any time during your treatment.
2. No psychiatric medication/ anti-depressants/ tranquilizers of any kind permitted whatsoever. Anyone on psychiatric medication will be weaned off by our doctor. No exceptions!
3. No violent, threatening or abusive behavior.
4. No will-full damage to and/or destruction of property.
5. No exclusive or sexual relationships with other peers.

Breaking the following rules, may lead to you being discharged from treatment:

1. Having knowledge of another resident breaking the above-mentioned rules, without reporting it to staff.
2. Tell the truth at all times, this is the beginning of your recovery.
3. You are expected to be timeous at all times, and to fully participate in all aspects of the timetabled program, to the best of your ability.
4. All drugs and/or medications, offensive or dangerous weapons, CD players, walkmans, cellphones etc. must be handed in to a staff member on arrival at Walking With Winners.
5. Walking With Winners Recovery Centers reserves the right to randomly screen residents, at any time, for alcohol and/or drug use at the residents expense.
6. You are expected to complete all assignments to the best of your ability, and to hand them in timeously.
7. No gambling
8. No borrowing or lending of any money or goods.
9. No tattooing, body piercing etc. while in treatment.
10. Smoking is not permitted anywhere in the building at Walking With Winners. Smoking is only permitted in the, clearly marked, designated areas.
11. No residents are allowed to exchange telephone numbers with one another, or hook up on weekend outings or ten days.
12. No drinking or drugging on weekends out. No medication is to be taken without consent from Pastor Dave or Isobel Barber.

General Rules and Expectations:

1. We are all subject to the word of God. All residents are accountable for their actions and are expected to work within the boundaries set out therein. Residents are all subject to all Walking With Winners rules.
2. No food or drinks allowed in the bedrooms, entertainment area or as stated by management.
3. No swearing, drug talk or sex talk.
4. Visits are entirely at the Pastor's discretion. Girlfriends have to be approved each visit, no expectations.
5. Visiting hours are only on Saturdays from 14:00 - 17:00. Only immediate family allowed.
6. No visitors in resident's rooms. No resident is allowed to visit with other residents families.
7. No relationships, of any kind, between residents and other people's families will be allowed.
8. All literature, clothing, and any other items entering the premises will be screened and searched. Anything not in accordance with the word of God, will be confiscated and destroyed.
9. No resident is allowed to leave the premises, without permission from management.
10. General etiquette is expected whilst in group and while eating.
11. Personal hygiene is also an important part of routine. Residents are expected to shower and shave everyday.
12. No feet on the couches, in the entertainment area or the library.
13. CD players, walkmans, computer games, MP3 players, monies, valuables etc. are not allowed, and must be handed in on arrival at Walking With Winners, to staff for safe keeping.
14. Walking With Winners staff will keep an account for you, so that you can purchase cigarettes, toiletries etc.
15. It is your responsibility to ensure that you have sufficient funds available to meet your needs.

16. Telephone calls may only be received after the first two (2) weeks, either on a Monday and Wednesday, or a Tuesday and Thursday, between 17:00 – 21:00, for a maximum of ten (10) minutes per phone call per day i.e. two telephone calls per week. Calls are at the Pastor's discretion. Only immediate family, unless arranged otherwise with management.
17. Residents must be appropriately dressed at all times. Shoes must be worn during group and church etc.
18. The kitchen is out of bounds, unless supervised.
19. Bedrooms are expected to be neat and tidy at all times. Beds to be made before smoking, clothes packed away and neatly folded etc.
20. I give my consent that my religious minister or any other relevant support group may be informed of my admission to Walking With Winners.
21. Walking With Winners reserves the right to make inquiries regarding my income information.
22. I accept that we will be involved in a daily work program, called "Physical Therapy" which includes garden and yard work, kitchen work, house cleaning, keeping rooms clean, general maintenance and upkeep of the facility and grounds.
23. No impulsive or sudden decisions will be entertained.

By signing this, I furthermore release any and all media and/or forms of media (photographs and/or video recordings) to Walking With Winners Recovery Centre, to use for any and all promotional and/or educational purposes.

I, the undersigned resident, by my signature hereunder, declare that I have read, understood and accept the Terms and Conditions set out herein above, voluntarily and without duress.
